Structure, governance & management

- The Districts governing documents are those of The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.
- The District is a trust established under its rules which are common to all Scouts.
- The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.
- The District is managed by the Board of Trustees, (the executive committee), the members of which are the 'Charity Trustees' of the Scout District which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.
- Trustees complete 'Essential Information for Executive Committee' training
- This trustee board exists to support the District Commissioner in meeting the responsibilities of the appointments and is responsible for, amongst other things:
 - Managing the District finances and property
 - Supporting the development of Scouting
 - Posiitvely promoting Scouting
 - Operation of an appointments committee
 - Opening and closing Groups in the area

Risk & internal control

The trustees discuss the risks and opportunities of all proposed activity on an ongoing basis. It is a priority of the trustee board to review, and create systems to mitigate, risks over the coming year. Known areas of concern that have been identified are:

- Reduced income from fund raising. The District is primarily reliant upon income from members in constituent Groups and Units. The District holds a balance of funds to ensure the continuity of activities should there be a major reduction in income. The District continue to look to external organisations to help fund large scale projects.
- The District owns Olympia HQ and the lease to Tamarak Campsite. Like all assets, they require ongoing investment and upkeep. Olympia has benefitted from signifcant grant fund investment over the last year. Tamarak has recieved a long term grant to help bring the site up to safety standards following a break in activity due to the pandemic. Both assets would benefit from long term development plans to ensure the charity maximises their potential.
- The District has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include 2 signatories for all payments and a comprehensive insurance policies to ensure that insurable risks are covered.

Reserves policy

In 2023 the District Trustee Board established a finance sub committee, which was tasked to create a draft reserves policy for approval by the Trustee Board. It is anticipated this policy will be approved at the next Trustee Board meeting following the AGM.

The accounts for each entity have been prepared with a consolidation of the results at a District level. The consolidated accounts have eliminated any inter-entity transactions (highlighted above) to avoid any duplication (see notes 2-5). For example, the grant from District to Tamarak would show as income to Tamarak and an expense to District, with a further external expense to the third parties. By elimination, only the external costs are shown in the accounts. The individual entity costs would include all transactions.

Notes (numbers as per table above):

- 1. Net income from capitation to carry into 2022/23 is £4,270 (427 x £10.00)
- 2. Grant funding from District to Tamarak to facilitate safe and legal opening after Covid-19 lockdowns
- 3. Defibrilator and associated equipment purchased and accounted for by Olympic HQ in 2021/22, re-imbursed in 2022/23
- 4. Fundraising income for Tamarak paid into the District bank account and then transferred to Tamarak
- 5. AGM costs included hog roast and inflatables costs that were committed from a cancelled 2021/22 event (Leaders Weekend) and utilised at the AGM

District Accounts

As noted above, the District has net membership fees of £4,270.00 to carry forward into 2023/24. By comparison, the brought forward was £770.00 due to reduced fees as the District was emerging from lockdown. Expenditure plans for the forthcoming year need to be mindful of the available resources, with any requests for financial support to be submitted prior to commitment.

Olympia HQ Accounts

The majority of funding came from grants received from three organisations, this includes ring-fenced funding for new gate/path (£500) and solar power (£7,500). Rent received was £1,819.00.

The main item of expenditure was the rendering of the scout hut £16,380.00.

Selby Explorers Accounts

During the year £10,525.00 was received in respect of Haarlem, with expenditure of £12,339.40; the trip will take place in August.

Other income has come from subscriptions and activities, with expenditure incurred in respect of those activities, insurance, badges and administration costs.

Conclusion

This year has seen some significant expenditure as the District re-builds from the Covid-19 lockdowns and restrictions. Much of this has been "one-off" in nature, eg Tamarak and Olympia HQ improvement works, but has shown how tight the finances of the District are. Prudent budgets for the next year have been prepared which show only modest surpluses are to be made, with minimal self-funded investment in the District assets.

In light of the deficit for the year, available resources have been reduced by 17.5%.

On a positive note the Autumn 2022 census reported 427 members compared with 355 for the previous year, some 20% increase.
